INFORMATIVA D.Lgs. 196/03

We would like to inform you that Globaljig International S.r.l. collects and uses your personal data following Directive 196/03 (Directive for the Protection of Personal Data) and respecting the obligations of reservedness our company is bound to. Data processing, in fact, will be always done lawfully and legitimately. Data will be correct, complete, relevant and when needed, updated.

Globaljig International S.r.l. according to paragraph 13 of above mentioned Directive has to inform you about the scope and the use of data.

SCOPE OF PROCESSING

Personal data regarding yourself/your company will be used either for commercial or administrative purposes, strictly linked to our activity and nothing else.

The above processing will involve just the necessary data to allow the carrying out of GLOBALJIG'S commercial activity as well as to make its relationships with customers, suppliers and other contractors simple and secure.

MODALITY AND DURATION

Data processing will be done by using proper instruments to guarantee reliability and reservedness

Personal data will be managed by computer as well as on paper, always following principles of reliability and reservedness on processing personal data (for further information about specific reliability measures adopted, please forward a specific request to our address below)

Personal data will be kept for the necessary period related to the purpose they have been gathered and processed for and no longer than that. Therefore, it will be impossible after the period related to the purpose of the processing itself (gathering, elaboration, etc.), to identify the person concerned by means of personal data.

Given right listed in art. 7 Directive 196/03, we guarantee to the person concerned the possibility to cancel (totally or partially) his data and therefore to cease any data processing. We have to precise that a cancellation request (total or partial), could lead to the impossibility for Globaljig International S.r.l. to continue or to start eventual commercial or contractual business relationships.

Any legal obligations related to data already given remain untouched.

KIND OF DATA

The kind of data transfer is optional, nevertheless, we must state that faulty or partial information could cause impediment or impossibility to precisely fulfil the present and future contractual obligations.

The type of data prepared by Globaljig International S.r.l. is based on a previous analysis of the necessity related to the specific kind of business relationship which made the collection of personal data necessary.

Whenever the collected data enters in the category of "sensible data", it will be subject to all the security measures of Directive 196/03 and all the limitations established by this Directive.

COMMUNICATION AND CIRCULATION OF DATA

Apart from all the communications necessary to comply with law or contracts, all the collected data could be forwarded to:

- Third companies entrusted to accomplish contractual obligations taken by Globaljig International S.r.l. or third parties, commercially linked to GLOBALJIG'S activity, that need personal data in order to accomplish their business linked with GLOBALJIG'S.
- Outside parties carrying out specific tasks for Globaljig International S.r.l..
- Public Administration and Judicial Authorities for legal purposes.

Data processing could also consist in their communication or circulation abroad, either inside or outside the EC.

In case of communication to third parties, following above parameters, we guarantee a previous control through the owner regarding the respect of the necessary measures (as stated in Directive 196/03) by the third party receiving the data (under the actual limits of GLOBALJIG'S possibilities to verify and control)

Data will be always recognizable by the owner and his authorised delegates who are explicitly and formally nominated by the owner himself by nominal act which indicates the specific authorisation profile.

RIGHT OF PERSON CONCERNED

We inform you that you can use the rights recognised by article 7 of the Personal Data Protections Act, by directly addressing Globaljig International S.r.l..

Follows art. 7 Directive 196/03:

1. *The person concerned has the right to receive confirmation of the existence or absence of personal data, even though not registered at that moment, and their communication in a comprehensible form.*
2. *The person concerned has the right to get indication of:*
 - a. *Origin of the personal data*
 - b. *Aim of processing it*
 - c. *Logic applied in case of processing by computer,*
 - d. *Information on the superior of the people responsible and the legal representative according to art. 5, paragraph 2*
 - e. *Third parties or categories of third parties to whom data can be forwarded to or who could apprehend data acting as Government representatives, responsables or assigned persons.*
3. *The person concerned has the right to receive:*
 - a. *Updates, rectification and in case of interest , integration of data.*
 - b. *Cancellation, transformation in anonymous form or the total block of data treated unlawfully, including those that do not need conservation related to the purposes they have been taken for or processed.*
 - c. *Certification that the operations ref. to letters a) and b) have been notified , even regarding their contents, to the people the data has been communicated to or spread to, except for the case that this is impossible or it involves a big disproportion of efforts contrasting with the right defended.*
4. *The person concerned has the right to totally or partially oppose:*
 - a. *For legitimate reasons linked to the processing of the personal data, even though data would be relevant to the gathering finality*
 - b. *To processing of their personal data for the purpose of sending promotional material or direct sales or market research or commercial communication.*

We notify as well that the above mentioned rights can be executed by its owner following the depositions of art. 8, 9 and 10 of Directive 196/03.
